ActionAid Zimbabwe is seeking an individual consultant or consultancy team to undertake a comprehensive end-of-project evaluation for the Youth Hub in Harare South – Dignified Lives and Decent Livelihoods for Young People project, which is concluding its 5-year implementation period (2021–2026). The project aims to empower vulnerable young women and men living in high-risk environments through a Youth Hub model that provides vocational skills training, psychosocial support, Sexual and Reproductive Health and Rights (SRHR) education, and platforms for civic participation and engagement. Project activities were implemented in Hopley, Chitungwiza, and Harare South. The primary task of the consultant will be to assess project performance, outcomes, impact and sustainability in line with OECD-DAC criteria, UNEG standards and ActionAid's Human Rights-Based Approach.
